The Hazardous and Radioactive Materials Bureau (HRMB) of the New Mexico Environment Department has reviewed the Disclosure Forms, sent by you on October 4, 1996, for Rinchem Company, Inc., (RCI). The Disclosure Forms are required of every applicant for a permit pursuant to the New Mexico Hazardous Waste Act. HRMB has determined the information provided on the forms is deficient; therefore, the forms are being returned to you with this letter.

The instructions provided with the various Disclosure Forms direct that "ALL QUESTIONS MUST BE ANSWERED". Examples of the deficiencies are the *Personal History Disclosure Forms* for Mr. William W. Moore, Mrs. Sharol R. Moore, and Mr. James H. Moore Jr. (items left unanswered on page 5, items 2.a. and 3.). An additional copy of the *Subsidiary Disclosure Form* is enclosed. This form, whether applicable or not, must be completed and submitted to HRMB.

The *Governmental Agency Disclosure Statement* you sent is not required since RCI is a private enterprise. In its place, a *Business Concern (Governmental Entity) Disclosure Statement* should be submitted. A copy of this form is enclosed. Please complete and return it to HRMB.


