Dear Ms. Wagner:

The New Mexico Environment Department (NMED) hereby approves the Advanced Chemical Transport's/Rinchem Company, Inc.'s (the Permittees) Class 1 Permit Modification request with prior approval for the Hazardous Waste Operating Permit for the Container Storage Facility (CSF), dated April 11, 2012. The proposed modification includes the addition of an adjacent yard located at 6141 Edith Boulevard to the Container Storage Facility's operating permit for equipment storage, roll-off storage, and potential 10 day storage of hazardous waste in trailers, until the Permittees are ready to move the waste into the CSF. The Permittees also requested the revision of Table H-1 of Permit Attachment H, Contingency Plan, by updating the Emergency Coordinator information to reflect current personnel responsibilities and contact information.

The proposed modifications were included in Enclosure A, the revised plan view of the CSF that includes the adjoining yard. Also included in the submittal were the Revised Figure 6, Facility Layout, and Figure 7, Site Plans of the CSF, for incorporation into the pending permit renewal application. These modifications will be addressed during the permit renewal process. Enclosed is the Emergency Coordinator list that the Permittees must incorporate into the current operating Permit's Permit Attachment H (page 3 of 9).


Further, the Permittees must send a notice of the modification to all persons on the facility

This notification must be made within 90 calendar days after the Permittees receive this approval letter, as required by 40 CFR § 270.42 (a)(ii), incorporated by 20.4.1.900 NMAC.
