Advanced Chemical Transport's 2011 biennial report was corrected to reflect the actual amount shipped for GM Flammable Aerosols 1103-04005 as 1,237 lbs., not 12,370,000,000 as originally reported and the initial report did not include two manifests of additional waste sent to Rineco in the latter part of the month of December 2011. The report did not reflect an additional 12,187 pounds of Hazardous Debris for Fuels waste stream 1111-18482, 10,645 pounds of Hazardous Debris for Fuels Class 9 waste stream 1111-18920 and 16,608 pounds of 1112-18971 Loose Pack Paints for fuels blending. All three streams were sent to Rineco and managed as H061 on manifest numbers 005113179 FLE and 005115487 FLE shipped on December 16th and December 29th respectively. I have included the corrected GM report for flammable aerosols as well as the new GM Forms for Loose Pack Paints 1112-18971, Hazardous Debris Non Processable Solids for Fuels (Class 9) No Benzene 1111-18920 and Hazardous Debris for Fuels (No Benzene) 1111-18482.

ACT agrees that the additional 39,440 (19 tons) applies to the waste generation report for 2011. A copy of this letter will be filed as an addition to our 2011 biennial in our operating record.
