Please review the charter, and if acceptable, sign the charter's last page. Return the charter no later than 31 Dec 92 to us at the above address.



Charter of the Cannon Air Force Base Installation Restoration Program Technical Review Committee

- I. NAME: This organization shall be known as the Cannon Air Force Base (CAFB) Installation Restoration Program (IRP) Technical Review Committee (TRC).
- II. PURPOSE: The purpose of this committee is to provide relevant state and local authorities the opportunity to review and comment on proposed remedial actions taken by CAFB under the DOD Installation Restoration Program (IRP).

III. APPLICABLE LAWS AND REGULATIONS:

- A. Actions taken by CAFB will be in accordance with the requirements of all applicable federal, state, and local laws and regulations.
- B. The selection and implementation of any remedial action will be in accordance with federal, state, and local applicable or relevant and appropriate requirements (ARARs) and will be protective of human health and the environment.
- C. The Environmental Protection Agency (EPA) and the Department of Defense (DOD) may adopt regulations or operating guidelines under the Superfund Amendments and Reauthorization Act (SARA) and the United States Code (USC) Title 10, Section 2705 governing the conduct of the IRP. Upon adoption of such regulations or guidelines, the provisions thereof will become part of this agreement and and take precedence over conflicting provisions of this agreement.
- D. CAFB has not entered into an Administrative Order and Agreement with EPA Region VI. CAFB is not on EPA's National Priority List (NPL). However, CAFB feels it is to the best interest of the base and local communities to establish a TRC allowing representation from local communities the privilege of reviewing documents developed under the subject program.

IV. STRUCTURE OF THE TRC:

- A. Membership of the TRC will consist of one designated representative from the Air Force (Chair), the New Mexico Environment Department (NMED), the EPA, and a member of the governing body of the local community. Whenever appropriate, local communities impacted by IRP activities at CAFB will be invited by the TRC to provide a public representative to serve as a member. Each member may provide technical or administrative support personnel as required.
- B. Meetings will be called by the Chair quarterly, or at the request of individual members as needed. Members and support staffs will serve without compensation. Agenda items will be submitted 30 days in advance to the Chair. The Chair will mail the agenda to the committee members seven days in advance of quarterly meetings.
- C. All expenses incident to travel and review inputs will be borne by the member's sponsor.

V. OPERATING PROCEDURES:

- A. Meetings will be held at CAFB or at an off-base location convenient to the affected community. The Chair will be responsible for writing minutes of each meeting and for dissemination of meeting minutes and other data requiring committee review and comments. Approval of prior meeting minutes will be an agenda item for each meeting.
- B. CAFB will send work plans, final reports, decision documents, proposed and final plans and other applicable documents that are to be reviewed by the TRC to EPA and NMED prior to the meeting for which these documents are to be reviewed. EPA Region VI will review all work plans and reports that relate to the HSWA permit for completeness and technical competence. Other documents will be reviewed as time allows. CAFB will send these documents to other members if sufficient copies are available, otherwise members will be notified where they can review the documents at CAFB. Members may submit written comments on the documents to the designated chairperson. Members are responsible for assuring that comments reflect the position of their constituency.
- C. The TRC shall have an opportunity to review and comment on all draft final and final plans, final reports, decision documents and other applicable documents pertaining.
- D. During quarterly meetings, CAFB will provide progress reports on IRP activities for review by the TRC. At a minimum, these reports will describe the IRP activities during the quarter.
- E. CAFB will prepare documents for presentation to the TRC. CAFB will submit documents and other reports to EPA and NMED for review and comment before they are presented to TRC. The intent of this provision is to ensure that all documents presented to the committee represent a coordinated Air Force, EPA, and NMED position. Nevertheless, it is recognized that a coordinated position on all aspects of a particular document may not be possible. If CAFB cannot accept a comment relating to the initiation, development, and selection of a response action, the comment and the reason for it not being accepted will be attached to the document at the time it is presented to the TRC. Regulatory comments will be included in the documents at the time of public disclosure.
- F. The TRC, in addition to facilitating the exchange of information, will attempt to resolve, through compromise, all issues and problems that may arise during the course of IRP activities.
- G. Final documents and associated comments reviewed by the TRC and TRC meeting minutes will become a part of the administrative record on which the selection of action will be based. The administrative record will be available for public review at on-base locations.

- H. Documents and correspondence will be sent to the members at the following addresses:

Correspondence will be sent to the other members at the addresses they provide to the chairperson. Documents will be made available for review by the other members at CAFB unless sufficient copies are available for mailing.

VI. CAFB will conduct public participation as provided in the CAFB Community Relations Plan.

VII. EFFECTIVE DATE, FLEXIBILITY, MODIFICATIONS:

- A. The effective date of this charter is the date of the last signature in Section VIII.
- B. This charter shall be amended as required by changes in state and federal laws or regulation.
- C. It is acknowledged that the Preliminary Assessment/Site Inspection information can result in some sites on CAFB being dropped from further investigation due to lack of evidence of a potential problem. Also, some sites may proceed with interim remedial action in the form of operable units prior to the total completion of the Remedial Investigation/Feasibility Study, if conditions warrant.
- VIII. The provision of this Charter shall be satisfied and considered complete when any member terminates the TRC.
