AFB - Fuels in soils ⇒ Not associated w/ oil-water separation?

The proposed plan for the additional investigation at SWMU No 70 is broken into two parts. Part I is use of a passive soil gas technique in an attempt to delineate the horizontal extent of contamination and estimate where the contamination is coming from. Part II is several soil borings. A minimum of eight soil borings are planned. At present the plans are to drill an approximately 150' boring at the apparent center of the contamination. Three 100' deep soil borings will be drilled within the apparent area of contamination and an additional four 80' soil borings are planned for the outer edge of the apparent contamination. Soil samples will be taken every 5 feet from 0-20 feet and then every 10 feet to the bottom of the boring.

The schedule of activities for this investigation may be found in Table 1. As this is a preliminary outline of the work to be completed, these dates are subject to change and should be considered to be +/- two weeks.
