- a. The Notice of Deficiency (NOD) for the RCRA Facility Investigation (RFI) Report on Landfill 3 and 4 Wells, issued by EPA Region VI, was answered by Cannon AFB on 31 Aug 95. Currently awaiting approval at EPA Region VI.
- b. The Workplan for the Phase III Appendix I RFI, Solid Waste Management Units (SWMUs) 86-90, was approved by EPA Region VI.
- c. The Interim RCRA Corrective Action to Remove/Replace/Remediate 19 oil-water separator sites (SWMUs) reached the 95% design stage. Formal submittal of the documents to EPA Region VI and NMED will be made in Oct 95.
- d. SWMU 113/Landfill 5 monitoring wells were sampled and Cannon AFB is awaiting the results. Submittal of data to NMED will be made after Cannon AFB receives the results.
- e. Soil borings and associated field work for SWMU 113/Landfill 5 was completed and the Draft RFI Report is being generated for submittal to NMED and EPA Region VI.
- f. Phase I Landfill I Workplan was approved by EPA Region VI and field work commenced 18 Sep 95.
- g. Phase II Appendix II & III RFI Reports are at EPA Region VI awaiting approval. Verbal contact was made by EPA implying a NOD would be issued for the reports the last week in Sep 95.
- h. The Data Quality Summary Report for SWMU 96 (SD-17; Old Entomology Rinse Area) was forwarded to EPA Region VI and is awaiting approval.
