Cannon Air Force Base hereby submits a No Further Action (NFA) Report for Fire Training Area 4 (FTA-4).

FTA-4, which consists of four solid waste management units (SWMUs) numbered 109, 110, 111 and 112, was recently remediated as part of a Voluntary Corrective Measures (VCM) action completed in Apr 05. A VCM Report was subsequently submitted to your bureau in Nov 05. Ms. Tammy Diaz of your staff reviewed the VCM Report and recommended, in a letter dated 7 Mar 06, that Cannon submit a Corrective Measures Implementation (CMI) Work Plan to complete the remediation since the VCM Report indicated there were three remaining "hot spots" in SWMU 109.

CAFB elects instead to submit an NFA request in lieu of preparation of a CMI Work Plan. As described in the attached "Final No Further Action Report for Fire Training Area No. 4" dated Jun 06, we believe NFA is required since there is little to no risk to the environment. If this report meets your approval, we will submit a formal Class III Permit modification requesting that the subject sites be placed on Table 2 (List of SWMUs and AOCs Not Currently Requiring Corrective Action) of the Cannon AFB Hazardous Waste Facility Permit No. NM7572124454.
