Dear Colonel Piech:

The New Mexico Environment Department (NMED) has received Cannon Air Force Base's (Permittee's) April 24, 2013 time extension request for submittal of a RCRA Permit Renewal Application. The request was received on April 26, 2013. NMED has completed review of the request, finds the request reasonable, and hereby approves a time extension for the Permittee's submittal of the RCRA Permit Renewal Application to June 13, 2013.

The Permittee's time extension request indicates in part that "[A]dditional time is necessary to submit proposals for "Corrective Action Complete" status of numerous environmental restoration sites at Cannon AFB..."

Note that the time extension approval only applies to submittal of the Permit Renewal Application and is unrelated to the Permittee's potential future submittal of proposals for Corrective Action Complete determinations.
