SUBJECT: Public Notice for One Class 3 Permit Modification Requests, Cannon Air Force Base

Dear Interested Citizen:

Enclosed is the Public Notice regarding one Class 3 Permit Modification request to modify the Resource Conservation and Recovery Act (RCRA) Permit NM7572124454 issued to Cannon Air Force Base (AFB), U.S. Department of Defense.

If approved, the proposed modification would grant a change in status to a Two Solid Waste Management Units (SWMUs) and One Area of Concern (AOC), as follows:

- The Permit Modification requests a change in status from Corrective Action Required to Corrective Action Complete without Controls for two (2) SWMUs and one (1) AOC, including SWMUs 91 and 103, and AOC A.

The enclosed Public Notice provides the location at which the related supporting documentation for this Permit Modification request can be reviewed, information regarding the public meeting, and procedures for submitting comments. Written comments must be based on the Cannon AFB proposal/supporting documentation. Notice of Petition (Proposal) for a Resource Conservation and Recovery Act (RCRA) Class 3 Permit Modification at Cannon Air Force Base (AFB), in Curry County, New Mexico (NM).
