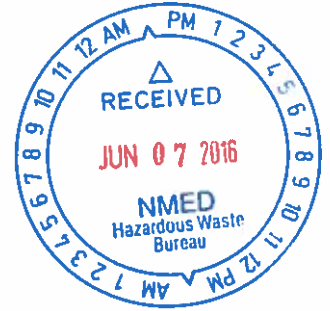

If approved, the proposed modification would grant a change in status from Corrective Action Required to Corrective Action Complete with Controls for Solid Waste Management Unit (SWMU) 127.

Notice of Petition (Proposal) for a Resource Conservation and Recovery Act (RCRA) Class 3 Permit Modification from Cannon Air Force Base (AFB), in Curry County, New Mexico (NM). Cannon AFB submitted a Corrective Action Complete Proposal for Solid Waste Management Unit (SWMU) 127 to the New Mexico Environment Department (NMED) that requests a change in corrective action status.
