The New Mexico Environment Department (NMED) has received Cannon Air Force Base's submittal titled *Release Assessment Report at Sites AOC CC, AOC EE, AOC II, AOC KKK, AOC OO, AOC PP, AOC QQ, SWMU 21, SWMU 30, SWMU 64, SWMU 65, AOC RR, and AOC UU* dated February 22, 2022. NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. The applicable review fees are listed in Table 5 of 20.4.2.208 NMAC. NMED will review the submittal after the appropriate fees have been received. The fee invoice is attached to this letter. Upon receipt of the payment, NMED will initiate a technical review of the submittal in accordance with 20.4.2.201.B(3) NMAC.

Payment is due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. If you disagree with the fee assessed, you may notify NMED in writing, at the address above, of the intent to appeal the invoice under the provisions of 20.4.2.302.A NMAC.

If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Mr. Dave Cobrain, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
