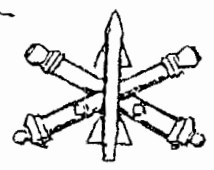
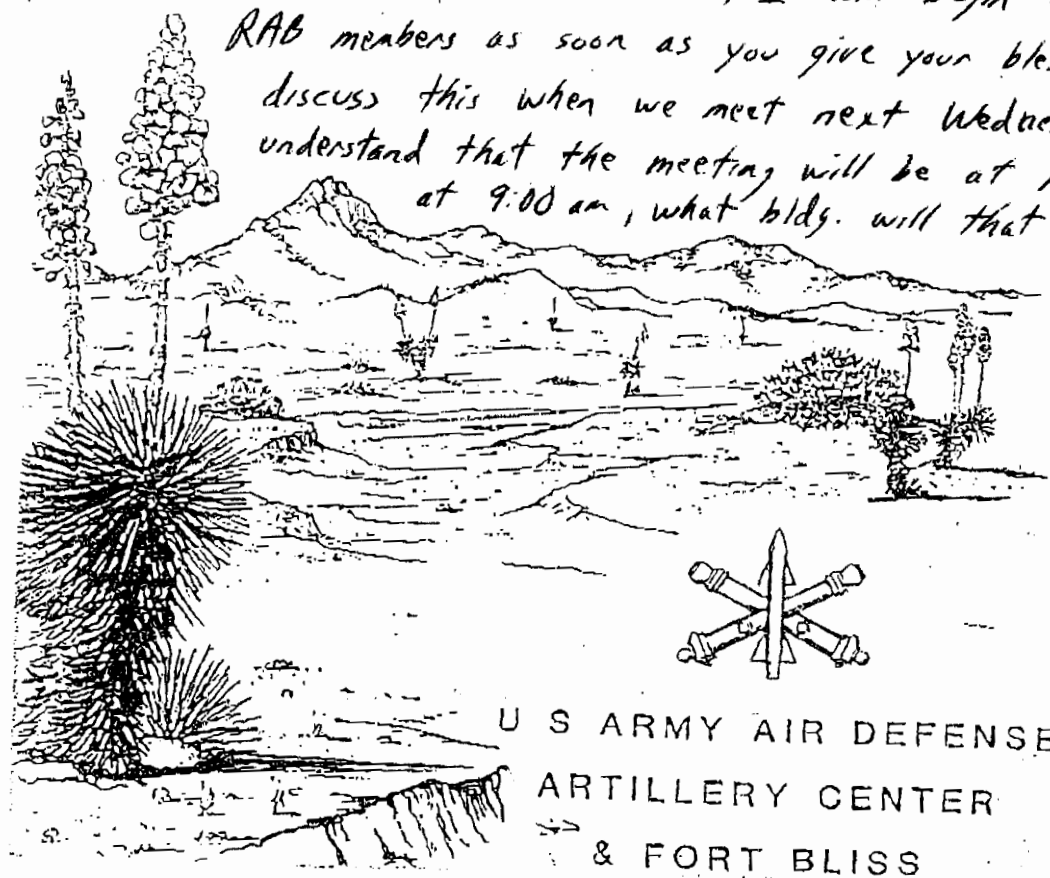

SUBJECT: Selection of Restoration Advisory Board (RAB) Members

1. Following are our recommendations for community membership on the RAB. Mr. Wilcox of SJA and I met on 21 March to review all RAB applications (enclosed). We have identified as best candidates for membership four (4) individuals from Texas, three (3) from New Mexico and two (2) alternates. We believe that the selections will give us a RAB that is diverse and representative of the community. I have contacted the regulators in New Mexico and Texas to request their participation in reviewing the 15 applications.
