Dear Mr. Cobrain,

This is to inform you that the US Army Air Defense Artillery Center and Fort Bliss has determined to reactivate Dona Ana Range 41 Detonation Area and have begun to schedule training of troops at this site. This action was taken in light of the increased operational tempo demanded by the Global War on Terrorism and the dramatic increase in war fighting troops coming to Fort Bliss.

Range 41 was historically used to train Soldiers whose military occupational specialty (MOS) required them to be able to destroy barriers and/or barricades blocking troop movement. The training at this site involved using Composition 4 (C-4) and other stable explosive compounds to destroy – or blow up – various objects such as metal drums, car bodies and the like. This training simulated destruction of similar item blocking the advancement of troops. Additionally the dramatic rise in the use of improvised explosive devices (IED) in Iraq and Afghanistan has required almost every Soldier to become capable of safely handling military moldable explosives so that when IED's are found they can be safely detonated.

Therefore it is requested that Dona Ana Range 41 Detonation Area, SWMU 26, FTLB-16, NMED ID # 7 be administratively removed from our permit referenced above. Please inform the undersigned of the procedure required to effect this action. The required Delegation of Authority by the Garrison Commander is attached.


## DELEGATION OF AUTHORITY
