Fort Bliss received your letter, dated 28 September 2007, granting an extension for the submittal of a revision to the Supplemental Resource and Conservation Recovery Act (RCRA) Facility Investigation (RFI) Report for the McGregor Range Oxidation Pond, Solid Waste Management Unit (SWMU) No. 19 (FTBL-21), Fort Bliss New Mexico. Although Fort Bliss' request was for an extension to 60 days after finalization (NMED approval) of the background values, an extension of 90 calendar days from the date of the letter was granted, resulting in a submittal date of 28 December 2007. Revisions to the RFI report cannot be made, however, until background values have been established for inorganic parameters at the McGregor Range.

Fort Bliss has secured funding and is moving forward with changes to the Background Sampling and Analysis Plan (SAP), addressing NMED comments, including changes in the scope of work for this effort. The SAP will be submitted on or before 31 January 2008 as requested by NMED. Fort Bliss will implement the background sampling upon NMED approval of the work plan. Fort Bliss has secured funding to finalize the McGregor Oxidation Pond RFI report, and intends to do so once NMED has accepted the results of the background evaluation.

Fort Bliss has secured funding to move forward with these projects in a timely manner, but cannot finalize the RFI report before background has been established. Fort Bliss respectfully requests an extension for the submittal of the revised RFI document to sixty (60) days from the milestone of finalization (NMED acceptance) of background values, per the attached schedule.
