Dear Mr. Ranson:

The New Mexico Environment Department (NMED) has reviewed the Department of the Army (Permittee) *Wastewater Sampling Results Report for September 2021 and Semi-Annual Wastewater Compliance Sampling for Meyer and Doña Ana – New Mexico Range Outfalls at Fort Bliss, Texas* (Report), dated October 6, 2021 and received on November 5, 2021.

The monitoring and associated reports are required by the January 2006 Settlement Agreement (2006 SA) between NMED and the United States Army, Fort Bliss Air Defense Artillery Center. The Permittee has fulfilled its obligation to conduct semi-annual sampling in September 2021 and submit sampling results and wastewater flow monitoring reports to NMED.

The wastewater volumes to the Doña Ana and Meyer Ponds measured between April 2021 and September 2021 were recorded as 1,776,000 and 10,200 gallons, respectively. These volumes are within the normal range. Additionally, none of the constituent concentrations in the wastewater samples collected during this sampling period exceeded the applicable regulatory limits.

The Permittee must continue to implement monthly flowrate measurement and semiannual sampling at the Doña Ana and Meyer Ponds and submit associated reports in accordance with the 2006 SA. The March 2022 reports must be submitted to NMED no later than **July 31, 2022**.
