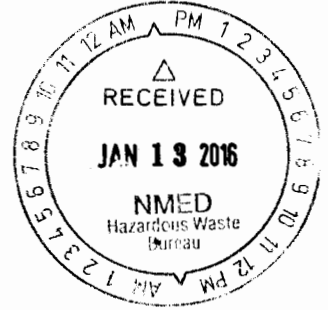

Wingate Activity Depot, McKinley County, New Mexico for review and comments. The 60-day Tribal review period for that document expired on December 27, 2015 and the Army has not received comments from either Tribe about this Work Plan.
