2. Please note the closure plan to be submitted on 15 May is the latest revision of the original closure plan, submitted 19 Jan 1989 (within the required 30 days of signing the Federal Facilities Compliance Agreement on 20 Dec 1988); the plan has been revised several times since then. Our records indicate two copies of the most recent revision were submitted to Mr Boyd Hamilton of the RCRA Permits Program on 18 Jul 1990 (Atch 1). The document to be submitted by 15 May is a major revision intended to completely replace the previous plan. The revisions account for studies conducted in the intervening time, and the schedule is tied to the construction of the new wastewater treatment plant, for which the contract is expected to be awarded in April 1995.
