The New Mexico Environment Department (NMED) has received Holloman Air Force Base's (HAFB's) Voluntary Corrective Measures Work Plan, Disposal Pit 63 (DP-63) for review. NMED has determined that site DP-63 is a Solid Waste Management Unit. Therefore, the New Mexico Hazardous Waste Management Fee Regulations (20.4.2 NMAC) require assessment of fees prior to formal review of this corrective action document. An invoice will be issued to you under a separate letter.

Payment is due within sixty (60) calendar days from the date that you receive the invoice. Should the Return Receipt be sent back to us without a date of receipt the fees shall be due sixty (60) calendar days from the date of this letter. Payment should be made by certified check or money order payable to the New Mexico Environment Department Hazardous Waste Permits Fund 339. If you need to request an extension of the sixty-day period, you must ensure that NMED receives the request a minimum of fourteen (14) calendar days prior to the end of the

sixty-day period. If you disagree with the fee assessed, you may file an Administrative Appeal under the provisions of 20.4.2.302.1 NMAC.
