The New Mexico Environment Department (NMED) has reviewed the document: RCRA Facility Investigation Report, Group 2-Building 882 (TU/US-C514), Holloman Air Force Base, New Mexico, dated September 2013, which was received on October 9, 2013. The subject report is hereby approved.

The Permittee may submit a Class 3 permit modification request (PMR) to NMED to change the status of Building 882 (TU/US-C514) from Corrective Action Required to Corrective Action Complete in accordance with 20.4.1.900 NMAC incorporating 40 C.F.R. §270.42(c) and the facility's RCRA Permit at Part 4, Appendix 4-B, Section III, *Determination of No Further Action*. The process for a Class 3 PMR includes requirements for public notice and for providing opportunity for public comment that are mandatory. NMED's preliminary determination that corrective action is complete is subject to NMED's reservation of rights to require additional corrective action on the basis of new information, including information that may be provided to NMED in public comment.
