
The New Mexico Environment Department (NMED) has reviewed the document: *DP-30/SD-33 Grease Trap Disposal Pits and Cooking Grease Disposal Trench (SWMU 113B) Accelerated Corrective Measures Completion Report, Holloman AFB, Alamogordo, New Mexico*, dated July 2013, which was received by the NMED on September 3, 2013. The subject Accelerated Corrective Measures Completion Report is hereby approved.

NMED does not agree with the recommendation presented in the report that corrective action has been completed for Solid Waste Management Unit (SWMU) 113B. Additional corrective measures for SWMU 113B have already been proposed in a work plan submitted by Holloman Air Force Base in September 2014. The request for a corrective action complete determination for SWMU 113B will be reconsidered after the work proposed in the recently submitted work plan has been completed, subject to any required revisions to the plan, and the results of the additional work submitted for review by NMED.
