The New Mexico Environment Department (NMED) received the *Final Fiscal Year 2022 Groundwater Monitoring Report SS017 - Base Exchange Gas Station Fuel Spill (AOC-Q), October 2022*, on October 26, 2022. The NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. 

If payment is transmitted electronically, then you must submit a letter to Mr. Dave Cobrain, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
