Background

The Environmental Protection Agency (EPA) issued a hazardous waste permit to Kirtland Air Force Base (Kirtland) on November 14, 1990. The permit requires the investigation of approximately 200 Solid Waste Management Units (SWMUs). The SWMUs include landfills, surface impoundments, septic tank systems, fire training areas, oil water separators, and radioactive burial sites. The investigation of these SWMUs has been divided into three parts: Appendix I, Appendix II, and Appendix III. Work plans have been submitted for all three (3) appendices and investigations are currently underway.

Proposed Permit Changes

Kirtland has requested that their permit be modified to:

1. Add six (6) newly identified SWMUs;
2. Delete four (4) SWMUs that will be investigated by Sandia National Laboratories (Sandia) and are already listed on Sandia's permit;
3. Delete two (2) SWMUs that are being investigated by Kirtland under the New Mexico Underground Storage Tank (UST) program.

The following additional administrative changes have been made to the permit:

1. The address and contact person for the New Mexico Environment Department has been updated on page 8;
2. The due date of the draft RCRA Facility Investigation (RFI) Report has been changed on pages 19 and 37 to correct a discrepancy in the original permit. Draft RFI Reports are due ninety (90) days following completion of RFI field work, or as specified by the Administrative Authority.
