In accordance with the provisions of Module IV F.1, of the Kirtland AFB RCRA Permit Part B, issued 10 October 1990, we are notifying you of three sites recently identified as potential Solid Waste Management Units (SWMUs). These sites are:

- a. De-ionizing unit leach field at Building 1026.
- b. Unlined drain pit serving test cell in Building 765.
- c. Buried 55-gallon drum near Building 768.

This serves as initial notification for the above sites. We have already notified EPA Region 6; their response is at Atch 1.
