Dear Col. Maness and Mr. Pike:

The New Mexico Environment Department (NMED) has received the U. S. Air Force's (Permittee) letter dated June 20, 2011, signed by Mr. Thomas Berardinelli, requesting a modification to the Groundwater Investigation Work Plan for the Bulk Fuels Facility Spill, Solid Waste Management Units ST-106 and SS-111. The Permittee proposes to increase the length of the well screens at 10 new wells yet to be constructed across the water table. The screen lengths are to be increased from 20 feet to 30 feet, due to the rising, and anticipated continuing rise, in the water table.

While such an increase in screen length would allow wells to monitor conditions at the water table for a longer period of time due to the rising water table, unacceptable dilution of groundwater samples can be undesired result of longer screen lengths. Nonetheless, NMED agrees with the proposed modification of well screen lengths provided that the wells are initially installed with no more than 15 feet of their screened intervals situated below the water table. Furthermore, should the saturated screen length increase to 25 feet or more after the wells are installed, the wells must be replaced if required by the NMED.


