Dear Col. Maness and Mr. Pike:

The New Mexico Environment Department (NMED) has received Mr. Thomas Berardinelli's letter of August 5, 2011, requesting an additional 30 days to submit quarterly reports for corrective action activities being conducted at the U. S. Air Force ("Permittee") Kirtland Air Force Base Solid Waste Management Units ST-106 and SS- 111, collectively known as the Bulk Fuels Facility Spill. The Permittee requests the additional time to prepare and submit the reports due to the large number of monitoring wells that require sampling for groundwater and soil-vapor, and monitoring of four soil-vapor extraction systems. NMED finds that the request is based on good cause. The request is hereby approved.

The original schedule for submittal of quarterly reports was set forth in NMED's letter of June 4, 2010. The new schedule is summarized below in the following table.

2	April 1 through June 30	September 30
3	July 1 through September 30	December 31
4	October 1 through December 31	March 31


