Pursuant to the provisions of the Defense Environmental Restoration Program (10 USC Part 160, *Environmental Restoration*) (DERP), Kirtland Air Force Base (KAFB) has conducted preliminary assessments and site inspections of the Military Munitions Response Program (MMRP) sites within the boundary of the installation.

KAFB's restoration personnel have recently completed the Proposed Plan for No Further Action as well as the Removal Action Complete Report for MMRP sites TS775 and TS776.
