The New Mexico Environment Department (NMED) has received the U. S. Air Force's (Permittee) letter dated May 29, 2013, concerning its request to withdraw the plan *In-Well Treatment Interim Measures Work Plan, Part 1, Data Gathering and Analysis Plan, Bulk Fuels Facility Spill, Solid Waste Management Units ST-106 and SS-111*, dated December 2012 (hereinafter referred to as the Work Plan). The letter was submitted in response to NMED's March 27, 2013, Notice of Disapproval (NOD) issued for the Work Plan. In order to eliminate confusion in NMED's records for the Bulk Fuels Facility Spill related to the Work Plan, the NMED considers the Work Plan to be withdrawn in its entirety. All other issues addressed in the Work Plan that were discussed in NMED's NOD, if those issues remain unresolved, must be addressed in separate correspondence.
