The New Mexico Environment Department (“NMED”) is in receipt of the U.S. Air Force’s (“Permittee”) letter, dated December 15, 2017, requesting an extension to submit a work plan for the drilling and installation of new water table groundwater monitoring wells and modifications to the Quality Assurance Project Plan (“QAPP”) for groundwater monitoring from the original deadline of December 15, 2017 to January 5, 2018. NMED hereby approves the request.

NMED has received the revised work plan for continuous coring in the vadose zone referenced in the extension request letter. This revised work plan is currently in NMED review and will be addressed under a separate response letter.
