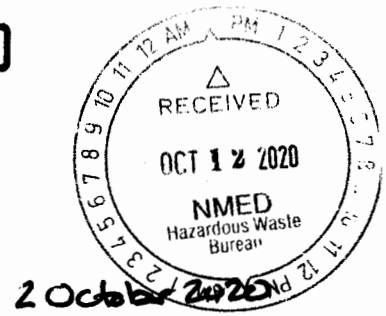

AFFIDAVIT OF COLONEL DAVID S. MILLER

Per 20.4.2.211(A) NMAC, the annual fee shall be waived for hazardous waste management units for which the owner or operator provides documentation to the New Mexico Environment Department (NMED) that Resource Conservation and Recovery Act (RCRA) related waste management activities did not occur at the unit during the previous calendar year. This affidavit serves as documentation for units under my management in calendar year 2019.

The following units under Kirtland AFB management did not perform RCRA related waste management activities during calendar year 2019:

- EOD Subpart X Open Burn Facility - hazardous waste treatment operations at the open burn unit ceased in May 2008. Kirtland AFB delivered the official notification of intent to close the open burn unit on 28 September 2009 in accordance with NMED Stipulated Final Order HWB-09-00(CO) and Settlement Agreement.
- EOD Open Detonation Facility - hazardous waste treatment operations at the open detonation unit ceased in August 2010. The closure plan for the open detonation unit was originally submitted on 8 October 2010.

As per 40 C.F.R. § 270.11, I certify under penalty of law that this affidavit was prepared under my direction or supervision according to a system designed to assure that qualified personnel properly gather and evaluate the information submitted. Based on my inquiry of the person or persons who manage the system, or those persons directly responsible for gathering the information, the information submitted is, to the best of my knowledge and belief, true, accurate, and complete. I am aware that there are significant penalties for submitting false information, including the possibility of fine and imprisonment for knowing violations.
