The New Mexico Environment Department (NMED) has received the *Periodic Monitoring Report, Solid Waste Management Unit 6-24, Former Manzano Sewage Treatment Facility, (WP-16), February 2022* (Report), dated February 24, 2022, and received February 28, 2022. NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. NMED will review the submittal after the appropriate fees have been received. The fee invoice is attached to this letter. If payment is transmitted electronically, then you must submit a letter to Mr. Dave Cobrain, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
