The New Mexico Environment Department (NMED) has received *Periodic Monitoring Report for April-June 2021, Bulk Fuels Facility Solid Waste Management Units St- 106/SS-111*, dated November 2021 and received November 23, 2021. NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. If payment is transmitted electronically, then you must submit a letter to Mr. Dave Cobrain, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.


