The New Mexico Environment Department (NMED) has received *Periodic Monitoring Report for January–March 2021, Bulk Fuels Facility Solid Waste Management Units St- 106/SS-111*, dated July 2021 and received July 23, 2021. NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC.
