This letter is in response to the New Mexico Environment Department (NMED) Request for Information, Kirtland Air Force Base, New Mexico, EPA ID # NM9570024423, HWB-KAFB-19-012 dated May 20, 2022.

The Air Force respectfully requests a 90-day extension from June 20, 2022, to September 19, 2022, for the submittal of the requested information as indicated in the May 20, 2022 letter. The information is to include all groundwater and light non-aqueous phase liquid (LNAPL) gauging field forms from all activities by all subcontractors working on the BFF site from January 1, 2020, to the present, including but not limited to measurements collected during quarterly monitoring activities, pilot test activities, site investigation activities (e.g., pre-drilling activities, drilling activities, and post drilling activities) as well as cross-sections produced by EA Engineering, Science, and Technology, Inc. as referenced in the May 20, 2022 letter. The information provided will include a tabulated searchable spreadsheet of the data as well as the handwritten field forms as requested in the May 20, 2022 letter.

This extension will allow the Air Force adequate time to compile all the requested information including conducting a thorough administrative and technical review of the requested cross-sections. However, please note the Air Force is unfamiliar with the requested cross-sections as they are not part of the official project record. In addition, the letter requested all gauging data through May 20, 2022. Subsequently, a portion of the requested data set has not yet been reviewed by the Air Force or submitted to the NMED for consideration. The requested time will allow the Air Force to research the referenced cross-section request and afford for review of the preliminary gauging data for acceptance by the Air Force prior to submittal. Finally, this extension will allow the Air Force sufficient time for the Commander or Vice Commander to review, approve, and sign the completed response package.
