The New Mexico Environment Department (NMED) has received the Kirtland Air Force Base (Permittee) letter requesting an extension of time to submit the Phase II RFI Work Plan, dated April 21, 2021. The work plan submittal is required by NMED’s September 25, 2020 *Approval with Modifications for the Phase I RFI Report for the Bulk Fuels Facility, Solid Waste Management Units ST-106/SS-111* (site). The request asks for an indefinite extension of time until a mutual agreement is reached between NMED and the Air Force regarding the technical path forward for the site.
