The New Mexico Environment Department (NMED) has received *Periodic Monitoring Report Solid Waste Management Unit 6-24 (WP-016) Former Manzano Sewage Treatment Facility, September 2022 (Report)*, dated October 17, 2022, and received November 17, 2022. NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. NMED will review the submittal after the appropriate fees have been received. The fee invoice is attached to this letter. 
