The New Mexico Environment Department (NMED) has received the *Periodic Monitoring Report for July–September 2022*, dated December 2022, and received on December 15, 2022. If payment is transmitted electronically, then you must submit a letter to Mr. Dave Cobrain, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
