The New Mexico Environment Department (NMED) has received *Fiscal Year 2022 Long-Term Monitoring and Maintenance Activities Report Solid Waste Management Unit (SWMU) 6-1, Landfill 1 (LF-001); SWMU 6-2, Landfill 2 (LF-002); AND SWMU 6-4, Landfills 4, 5, AND 6 (LF-008), December 2022* (Report), dated December 21, 2022, and received January 4, 2022. NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. If payment is transmitted electronically, then you must submit a letter to Ms. Jessi Sanchez, NMED Hazardous Waste Bureau, at the address below indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.




