The New Mexico Environment Department (NMED) has received the *Station B RCRA Solid Waste Management Unit Assessment Report*, dated July 2022, and received on July 15, 2022. NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Order and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC.
