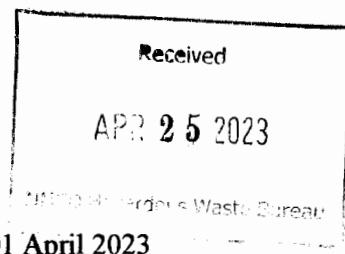

Dear Mr. Atkins

Pursuant to the provisions of the Defense Environmental Restoration Program, Kirtland Air Force Base (KAFB) has conducted assessments and site inspections of the Military Munitions Response Program (MMRP) sites within the boundary of this installation.

KAFB's restoration personnel have completed this Proposed Plan concerning the AL120b McCormick Unexploded Ordnance Munitions Response Site. This Proposed Plan recommends No Further Action for both Munitions and Explosives of Concern and Munitions Constituents. As required by 10 United States Code §2710(c)(2), Executive Order 12580, Executive Order 13016 and Office of Solid Waste and Emergency Response Directive 9200.3-60, the Air Force is submitting this Proposed Plan for the MMRP AL120b site for the Environmental Protection Agency's (EPA) records.

Please note that the EPA and Department of Defense (DOD) mutually agreed with the creation of the joint EPA-DOD guidance "Management Principles for Implementing Response Actions at Closed, Transferred and Transferring Ranges (2000)," that the Comprehensive Environmental Response, Compensation, and Liability Act is the preferred mechanism for performing investigation and cleanup of closed munition sites. For that reason, EPA Region 6's Superfund Division – not EPA Region 6's Resource Conservation and Recovery Act federal facilities staff should review MMRP documents.

Due to previous delays in reviews and the forthcoming expiration of the current contract, the Air Force respectfully requests that the EPA review this document and comment within 60 days from the date of this letter or request a 30-day extension to reply.
