Dear Colonel Vattioni and Ms. Clark:

The New Mexico Environment Department (NMED) met with the United States Air Force (AF) Kirtland Air Force Base (Permittee) on April 26, 2023 to discuss issues related to the required *Soil Vapor Monitoring Work Plan*, revised *Groundwater Monitoring Work Plan*, and the *Active Groundwater Sampling System Work Plan* (Plans). Pursuant to the discussions in the meeting, this letter provides written notice that the deadline for submittal of all three of the Plans is **July 31, 2023**. No further extensions will be granted, and the Permittee will be out of compliance if the Plans are not submitted by that date. The Plans must incorporate all of NMED's direction provided in NMED's letters dated September 16, 2022 and November 30, 2022 that address the Soil Vapor Monitoring Work Plan and NMED's November 8, 2022 letter in reference to the Groundwater Monitoring Work Plan and Active Groundwater Sampling System Work Plan.

The Plans will be reviewed in accordance with 20.4.2.201.B(4) NMAC. Data collected in accordance with the *Soil Vapor Monitoring Work Plan* and the *Groundwater Monitoring Work Plan*, once approved, will be used to assess site conditions and also be evaluated relative to data previously acquired at the site.
