Subject: Notification of Completion of Off-Site Waste Shipment to the Waste Experimental Research Facility (WERF), Idaho National Engineering Laboratory (INEL), Activity 3.1.1C in the Site Treatment Plan Federal Facility Compliance Order (FFCO), Rev. 1.0, June 12, 1996

The purpose of this letter is to inform you that 51 of the 104 items (15.89 cubic meters) comprising the isopropyl alcohol (IPA) waste stream (MWIR waste ID LA-W901, C PV Section 3.1.1, page 4) were shipped to INEL. Shipment occurred June 21, 1996, with receipt at INEL on June 24, 1996.

The October 4, 1995, FFCO issued by the New Mexico Environment Department (NMED) to implement the Site Treatment Plan (STP) at the Los Alamos National Laboratory (LANL), requires that "(W)ithin 45 days of receipt of waste at treatment facility," the Department of Energy (DOE) and/or the University of California (UC) "(P)rovide documentation to NMED that waste was received at off-site facility." This notification has been drafted in accordance with the requirements of Activity 3.1.1C on page 7 of the Compliance Plan Volume (CPV, Rev. 1.0) of the STP.

Also enclosed are copies of the signed manifests, as well as a Certification Statement. LANL's records and documents related to this letter are available to NMED's staff on request. Please contact me at (505) 665-5042 if you have any questions.
