Subject: Notice of Completion of Offsite Waste Shipment, Activities 3.1.3 (B), 3.1.4 (B), and 3.1.11 (B) in the Site Treatment Plan (STP), Los Alamos National Laboratory (LANL)

The purpose of this letter is to notify the New Mexico Environment Department (NMED) of completion of required activities set forth in the Federal Facility Compliance Order (FFCO). Activities 3.1.3 (B), 3.1.4 (B), and 3.1.11 (B) in the Compliance Plan Volume (CPV) of the STP require that the Department of Energy (DOE) and the University of California (UC), "Provide documentation to NMED that waste was received at off-site facility or provide notification of parallel option within forty-five (45) working days of receipt of waste at treatment facility or within 45 days after completion of parallel option." This letter follows the requirements of Section XX of the October 4, 1995 FFCO issued to DOE and UC.

A shipment that included STP covered wastes listed in CPV Section 3.1.3, "Aqueous Organic Liquids," MWIR Waste ID LA-W906; Section 3.1.4, "Organic Combustible Solids," MWIR Waste ID LA-W911; and Section 3.1.11, "Halogenated Organic Liquids," MWIR Waste ID LA-W907, and "Nonhalogenated Organic Liquids," MWIR Waste ID LA-W908, was made on December 18, 1998 and completed on December 21, 1998. Wastes were sent to the Diversified Scientific Services, Inc. (DSSI), Kingston, Tennessee. The total volume of STP waste shipped is 3.78 cubic meters. The volume of waste shipped from each treatability group is described in the following table.
