**SUBJECT: CORRECTION OF INFORMATION IN NOTICE OF COMPLETION
LETTERS (ENV-RCRA-08-103, ENV-RCRA-08-185, and ENV-RCRA-08-197)
SITE TREATMENT PLAN, FEDERAL FACILITY COMPLIANCE ORDER,
LOS ALAMOS NATIONAL LABORATORY**

This letter corrects information in Los Alamos National Laboratory's (LANL) letters submitted to NMED in FY08 regarding completion of activities in the Site Treatment Plan (STP), Federal Facilities Compliance Order (FFCO). The letters and the corrections are described below.

1. In a letter dated May 21, 2008 (ENV-RCRA-08-103), LANL notified NMED of a shipment completion in accordance with 3.3.4(B) of the Compliance Plan of the STP. At that time the new treatability group for *10-100nCi/g Waste* had been proposed but not yet approved. Therefore, there was no activity 3.3.4(C) in effect at the time that the shipment was initiated and completed. When NMED approved Revisions 17 and 18, the revisions did not include a requirement for notifying NMED of the completion of off-site shipments for this treatability group. LANL has requested that NMED include a new required activity for such notification in Revision 19 of the STP.
2. In a letter dated September 8, 2008 (ENV-RCRA-08-185), LANL notified NMED of the completion of off-site waste shipments in accordance with STP Activity



3.2(J). The total volume of shipped waste was reported as 14.78 m³ rather than 14.8955 m³. One shipped container (C07195722, page 4 line 7 of manifest 000365882JJK) was an 85-gallon container with a volume of 0.3215 m³ rather than 0.208 m³.

3. In a letter dated September 25, 2008 (ENV-RCRA-08-197), LANL referred to treatability group LA-W922 as 'combustible.' The waste should be listed as 'noncombustible.'


