Subject: Notice of Completion of Off-Site Waste Shipment Activity 3.1.5 (A and B), Compliance Plan, Site Treatment Plan, Federal Facility Compliance Order, Los Alamos National Laboratory

This letter notifies the New Mexico Environment Department (NMED) that Los Alamos National Laboratory (LANL) has completed required activities set forth in the Federal Facility Compliance Order (FFCO), Activity 3.1.5 (A) in the Compliance Plan (CP) of the Site Treatment Plan (STP). Activity 3.1.5 (B) requires that the Department of Energy (DOE) and Los Alamos National Security, LLC (LANS) notify the NMED of the shipment off site of waste included in the STP, and provide documentation of the receipt of the waste at an off-site treatment facility within 45 days of its receipt.

In addition, this shipment (container number W801832) marks the completion of Activity 3.1.5 (A) "complete shipment of existing waste to offsite facility for treatment, or complete parallel options" as proposed by letter dated 5-14-2014 (WM-DO-14-034) to the proposed FY12 Annual.

LANL made one shipment with a total of two containers of Noncombustible Debris Waste (LA-W922) to Perma-Fix Northwest on May 19, 2014 for treatment. The shipment was received at Perma-Fix Northwest on May 22, 2014. Shipment details are provided in Table 1. Documentation that waste was received at the aforementioned facility is provided in Enclosure 1.






