SUBJECT: NOTICE OF COMPLETION OF OFF-SITE WASTE SHIPMENT, FY16, 1ST Q, ACTIVITY 4.0, COMPLIANCE PLAN, SITE TREATMENT PLAN, FEDERAL FACILITY COMPLIANCE ORDER, LOS ALAMOS NATIONAL LABORATORY

This letter notifies the New Mexico Environment Department (NMED) of Los Alamos National Laboratory (LANL) requirement set forth in the Federal Facility Compliance Order (FFCO), Site Treatment Plan (STP), Compliance Plan, Section 4.0, on shipment of mixed transuranic (MTRU) waste.

The information below constitutes the Quarterly Report of shipments of Site Treatment Plan (STP)-covered mixed transuranic (MTRU) waste sent to the Waste Isolation Pilot Plant (WIPP) during the first quarter of Fiscal Year 2016 (FY16) – October 1, 2015 to December 31, 2015. DOE/LANS have not shipped to WIPP during the first quarter of FY16 due to the shutdown of WIPP on February 14, 2014. Table 1 reflects this with the zero total volumes.




