

UPDATE INSTRUCTIONS
LA-10300-M, REVISION 6 (November 1993)

Volume I:

- (1) Replace the existing title page (rev. July 1993) with the new one (rev. November 1993).

General Information

- (2) Replace the table of contents (pages GI-1 through GI-20) with the revised version.
- (3) Replace "Introduction" (pages GI-21 through GI-24) and "Document Control and Document Change" (pages GI-25 through GI-29) with revised versions.

Radiobioassay Chemistry

- (4) Replace the table of contents (pages R-1 and R-2) with the revised version.
- (5) Replace procedure R170 with the revised version.
- (6) Insert procedure R200 following R190.
- (7) Replace pages 1 and 2 only of R250 (this procedure has been retired).
- (8) Replace procedure R261 with the revised version.

Industrial Hygiene Chemistry

- (9) Replace the table of contents (pages IH-1 through IH-3) with the revised version.
- (10) Replace "Suggested Handling of Emergency Samples" (pages IH-11 through IH-16) with the revised version.
- (11) Replace procedure IH150 with the revised version.
- (12) Insert procedure IH185 following IH180.
- (13) Insert procedure IH211 following IH210.
- (14) Replace procedures IH260, IH270, IH274, IH275, and IH330 with the revised versions.

- (37) Insert procedure QCO180 following QCO170.
- (38) Replace procedures QCO190 and QCO200 with the revised versions.
- (39) Insert procedure QCO225 following QCO220.
