### May 6 Summary

NMED will get three copies of the next 10 RFI workplans.

I am to provide Diana with a second copy of our last meeting notes.

Diana gave me copies of the DOE Orders requested in 4/13/93 letter, excepting TRU Waste document No. JIO-025.

Site Specific Protocol review not yet complete, has gone to Dee Clark for technical editing. I should get it from Diana at our next meeting, 5/12/93, 2:00 pm.

Diana will call Ken Hargis re: Site Specific Health and Safety Plan.

I mentioned our upcoming public information potluck and our decision that it would be best if DOE or LANL staff not attend the first few of these meetings. Diana will check with Jerry Bellows on this issue.

### May 12 Summary

A request came from Dennis Olona to extend the Q clearances of five NMED people: Eloy Garcia, Terrie McKenzie, David Englert and Peter Monahan plus one other. Problem: some of these people have never had a Q clearance so extensions are not logical. Diana looking into this.

Diana gave me a copy of the site specific protocol reviewed through page 10.

On our proposed OUPs/AIP meeting: DOE thinks this would be difficult to coordinate and possibly acrimonious. I reiterated that in my view the meeting objective was not argument but an opportunity for DOE/LANL to see all at one time what comments which have come via our reviews to DOE/LANL and hear which ones we have been convinced are not valid or appropriate, which ones we are sticking to, and then to "shoot" at any of these which they feel are technically faulty. The idea was to all get briefed at one time on NMED's AIP current thinking.

I told Diana that after the Site Specific Protocol is finalized my program will draft a site specific work plan which will detail the work AIP will perform during FY 1994.

Diana has been involved with NEPA issues: objective is to get LANL into NEPA compliance within five years.

DOE agrees it doesn't need to attend our potluck meetings but would like the "right of refusal". I reiterated that the sense of the members of the various local activist groups was that DOE and LANL should eventually attend these meetings.
