Dear Mr. Johansen:

The Department of Energy Oversight Bureau (DOE OB) is formally submitting a list of our desired Environmental Surveillance (ES) locations for collecting split samples during the 1998 calendar year. It is the intention of the Bureau not to deviate from the attached list, but it should be clearly noted that this list only includes those sites in which our bureau intends to split or co-collect samples with LANL's Environmental Health and Safety 20 (ESH-20) Group. As per the agreement between DOE OB and LANL's ESH groups, it is to our understanding that LANL's ESH groups will schedule their 1998 ES sampling effort with our "wish list" in mind and submit a verbal or written 7 day minimum notification to our office in advance of sampling any sites on our list. This should allow us sufficient lead-time to better coordinate and conduct our ES sampling program.
