**SUBJECT: FY98/99 WORK SCHEDULES**

Dear Mr. Kieling:

Enclosed are the revised Los Alamos National Laboratory's Environmental Restoration (ER) Project Work Schedules for fiscal years (FY) 1998 and 1999. These schedules incorporate the changes agreed to in your September 16 and 17, 1998, discussions with Victoria George. These schedules supercede those provided to you on June 1, 1998.

The changes to the Work Schedules are as follows:

- 1) addition of a Resource Conservation and Recovery Act Facility Investigation (RFI) Report for Potential Release Site (PRS) 6-002 to the FY99 work schedule;
- 2) acceleration of the due date of the Sampling and Analysis Plan (SAP) for PRSs 73-004 (a,b) and 73-006 on the FY99 work schedule (note: PRS 73-004(c) has been removed from this SAP because it was proposed for NFA in September 1997 LA UR 97-3864);
- 3) a 30-day extension of the due dates for the RFI Report for PRSs 73-001(a,b,c,d) and the SAP for PRSs 53-006 (b,c,d,e);
- 4) removal of the RFI Reports for 21-011(c) and 50-003(a) because of aggregation strategy; and
- 5) removal of PRS 35-016(u) from the TA-35 RFI Report on the FY98 WS due to delays in receipt of data.

We appreciate your assistance in this matter and look forward to working with you next fiscal year. We hope to determine as early as possible how budgetary constraints and aggregation strategies may further affect the FY99 work schedule. We will continue to work closely with you and your staff on any refinements to the FY99 work schedule.
