**SUBJECT: POST REMEDIATION DATA AND SITE STATUS INFORMATION FOR
POLYCHLORINATED BIPHENYL SITES CLEANED UP UNDER TOXIC
SUBSTANCE CONTROL ACT (TSCA)**

Dear Mr. Yanicak:

In your April 14, 2000 letter to Joseph Vozella, titled "Post Remediation Data and Site Status Information for Polychlorinated Biphenyl Sites Cleaned up Under TSCA," you had expressed concern regarding issues discussed at the March 23, 2000 Surface Water Assessment Team (SWAT) meeting. In the letter, you requested that the SWAT and Environmental Restoration (ER) Project provide missing Standard Operating Procedure (SOP) 2.01 information on PCB sites listed in an earlier memo (EM/ER:99-053) by the end of July 2000.

Due to the Cerro Grande Fire, the SWAT and ER Project were unable to provide the requested information by the timeframe suggested. It is my understanding that much of the information has been gathered, however it was not submitted due to the fire. A SWAT meeting has been scheduled for October 30, 2000 to further discuss these issues. In that meeting, we hope to come to an agreement on when the remaining information will be delivered to your staff.
